Definition of Aggregate Allocated Capacity is modified as follows

"Aggregate Allocated Capacity" shall mean the sum total of Allocated Capacities under each Financial Bid corresponding to all Bids submitted by the Bidder/Participating Entity

Clause 3.3.1 stands modified as mentioned below:

Multiple Bids may be submitted by a "Participating Entity" in this Bid process under this RFS, provided however the following conditions shall apply:

- a) Financial Eligibility Criteria must be met for the aggregate Bid Capacity of all such Bids submitted by the Participating Entity, failing which all the Bids shall be summarily rejected.
- b) Lead Member of a Consortium shall not be allowed to part of multiple Bids in this Bid process, however other Members may be common between two Bids. For the sake of clarity, any Bidding Consortium in this Bid process shall have a single exclusive Lead Member, who is not a Participating Entity of any other Bid in this Bid process.
- c) List of Preferred Interconnection Substations shall be mutually exclusive across all such Bids submitted by the Participating Entity in this Bid process. No single Interconnection Substation shall be a part of two or more Bids submitted by these Participating Entities.
- d) Provisions of Point 7) of Clause 4.1.3 (C) Second Round of Allocation shall apply to the Participating Entity
- e) "Participating Entity" shall refer to Parent/Ultimate Parent/Affiliate/Group Company/Promoter of the Bidding Company and/or Member Company in the Bidding Consortium, all partners in the Bidding Firm, and the Bidding Individual and all Members of a Bidding Consortium.
- f) Aggregate Allocated Capacity across all Bids submitted by a Participating Entity shall not exceed 300 MW; however the Authorised Representative reserves the right to change Aggregate Allocated Capacity at any time during the Bid process without assigning any reasons whatsoever. And this limit shall be applied in the ranking order of allocation as specified in Clause 4.1.3 of this RFS;
- g) Relevant disclosures regarding the Participating Entity and its relationship with other Bidders in this Bid process shall be provided as per Format 6.7 of this RFS
- h) Any Bid shall have a single Technical Bid and one or more Financial Bids corresponding to such Technical Bid.
