(b). The IPC wing shall scrutinize the application and either share acknowledgement with the consumer for the application if it is in complete shape or information shall be given to the consumer for submission of the application in full shape within 3 working days through e-mail or letter in case any deficiencies. The consumer has to attend the deficiencies and submit the application in full shape within 3 working days, failing which the application is deemed rejected by the DISCOM.

- (d). The IPC wing has to initiate processing of the application, prepare and circulate the note file for approval through IPC wing, Commercial wing and Revenue wing upto CMD.
- (e). The IPC wing shall confirm the availability of Green Power with the DISCOM for supply to the consumer. The feasibility report for supply shall be provided against the consumer application along with plan for procurement of excess RE in case there is shortfall. IPC wing shall also maintain the record of total Green Energy purchased by DISCOM, RPPO obligation, Green Energy already supplied & approved under Green Tariff and balance available for Green Tariff consumers, on a monthly basis.
- (f). The Commercial wing and Revenue wing shall confirm any arrear dues against the consumer account or any legal issues/litigations/ court cases against the consumer account.
- (g). The DISCOM at its discretion may reject consumer application if there are any arrear dues or legal issue with the consumer. Also, the application may be rejected if the supply of green power is not technically feasible.
- (h). After necessary processing and approval from IPC, IPC, Comml & Revenue wings, the application shall be processed through concerned Directors up to CMD for approval.
- (i). CMD/ DISCOM shall be the final approving authority before issuing the approval letter for green energy tariff to the concerned consumer.
- (j). On approval/ rejection of the application; the decision in the following format shall be intimated to the consumer within 15 working days from the date of acknowledgment given to the consumer either through letter or email with a copy to the IPC, Comml & revenue wings.
